2017 SCL Forum Call for Scores

You must 1) be a member of SCL in good standing, and 2) agree to attend the 2017 Forum, to submit music.

You may submit up to two compositions, although only one will be selected.

All submissions must be received by 5 January 2017.

You may submit works for the following:

- SATB Choir (with or without piano accompaniment)
- Wind ensemble
- Combinations drawn from the following resources: clarinet, trumpet (C, Bb, picc. in A or Bb, or Flugelhorn), trombone, violin, cello, piano, percussion, solo voices (soprano, baritone)
- A quartet will be in residence at Washington and Lee, consisting of soprano voice, clarinet, percussion and piano. Members are particularly encouraged to submit works for this group, either as a unit or in subsets.
- Members are encouraged to provide their own performers when possible.
- Electroacoustic works are also welcome.

Only PDF and MP3 files are acceptable forms of submission. Works with multiple movements should be merged into single PDF and MP3 files.

Composers who are students of SCL members in good standing, or who become student members of SCL, may submit one (I) score of an instrumental or vocal composition for I-8 performers, or for electroacoustic resources. Compositions may also combine acoustic and electroacoustic sounds.

Students should have teachers who are SCL members, and students must be studying in SCL's geographical region: Alabama, Arkansas, Delaware, District of Columbia, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, South Carolina, Tennessee, Virginia and West Virginia.

February was a busy month for **Ken Davies** this year. Two performances at SCI-VI in February at Friends University included the premier of Twitter Rhapsody for clarinet and electronics by Dr. Sarunas Jankauskas and a performance of Strings Ablaze by the East Wichita High School Honors Orchestra, conducted by Eric Crawford. Oregon organist Christopher Wicks included Ken's Quietudes in church services in West Linn, OR in February. Dr. Joe Alexander and Ken performed Colloquium for trombone and tuba at the SCL Conference in Buies Creek, NC, and the following week SCI-III was the venue for performance of Ken's Around 3 A.M. at Marshall University in Huntington, WV. In April Dr. Jankauskas included Twitter Rhapsody on his recital at Wichita State. Also in April, Cody Ford premiered Ken's newly commissioned work, Euphonic Soundscape for euphonium and digital media, at Louisiana Tech University. Dr. James Boldin from Univ. of Louisiana at Monroe performed Ken's Brain Fantasies for horn and electronics on the same Louisiana Tech concert. In late April Ken received word his Strings Ablaze had won the Composers Concordance Generations Composition Competition in New York, which required attendance at the performance, but had to bypass the award due to a schedule conflict with the NACUSA National Conference at the University of Tennessee at Knoxville where Cody Ford once again performed Euphonic Soundscape.

Dark River for English horn and digital media was performed by freelance English hornist Caitlin McKeighan at the New Music on the Bayou Festival hosted jointly at Louisiana Tech U. and the University of Louisiana at Monroe in early June. The Mississippi University for Women in Columbus, MS hosted a NACUSA concert in October where Ken's electronic works of The Baleful Bride along with Judy's poems Day and Night and Artistry that Ken had set to music were performed. The same works were also included in mid-October at the University of Alabama at Birmingham on their NACUSA concert. Also in October Ken's Dark River, this time for alto sax and digital media, was performed at Mississippi University during the Christian Fellowship of Art Music Composers Annual Conference. Performances in November have included Twitter Rhapsody, once again performed by Dr. Jankauskas, this time at the Electroacoustic Barn Dance at the University of Mary Washington, Fredericksburg, VA and the premier performance of a work Dr. James C. Lebens of Laval University, Quebec City, Quebec, Canada commissioned for his recital at Laval, titled Plomberie partagée (Shared Plumbing). According to Dr. Lebens, this work is believed to be the first ever solo work composed specifically for the double bell euphonium. Remarkably, Dr. Lebens Facebook post and brief excerpt of the work has garnered over 12,500 views!

Arts at Queens University (Charlotte, NC) presented **Betty R. Wishart**, composer and Jeri-Mae G. Astolfi, piano on October 15th. The evening featured music from her recently released *Piano Sonorities* CD *Sonata II, Night Visions Suite, Variations on a Folk Melody, Remembrance*, and *Toccata II*. Night Visions Suite was also performed by Rachel Runnels at the Christian Fellowship of Art Music Composers conference at Mississippi College on October 7th.

Jeri-Mae Astolfi premiered Wishart's *Prelude I* and *Toccata III* and performed *Sonata II* on the Living Composers Concert at Campbell University on October 27th. Dr. Astolfi also performed *Sonata II, Remembrance* and *Toccata II* on the ArtsNOW Series at North Carolina State University on November 15th.

On November 15th Iwona Glinka premiered Betty Wishart's *Frolicking* for flute solo in Athens, Greece.

Harvey Stokes' Suite for Five Winds, a work written for the Hampton Roads Wind Quintet, was published recently by Ars Nova Music Press of Seattle, Washington. In April, 2017, chamber music performances of several of Stokes' works will be featured in a "Celebrating the Composer" concert as a part of the continuing Musical Arts Society Concert Series, which was established in 1921 at Hampton University by the composer/pianist Robert Nathaniel Dett.

John Poore has finished writing a 25-minute requiem, for SATB Chorus/Piano, narration, and power-point for the victims, families, and friends of those that lost their lives on 9/11/01.

Jonathan McNair (past-president) had a performance of his song cycle "An Earthen Man" for baritone voice and string orchestra with the Chattanooga Symphony on Oct. 2, 2016. A new work for piano, "Variations on St. Denio," was composed for and performed at the Memorial service for Molly Sasse French, former executive director of the Chattanooga Symphony, who died in October. The composer and his wife performed his arrangement of the tune "Ebenezer" for violin and piano on Sept. 22 at UT Chattanooga. A new work, "Postscripts" for piano (in four movements) was premiered by the composer on Dec. 2, 2016. He had two works chosen for performance at two College Music Society Regional conferences (Great Lakes and Southern regions) in 2017. His new String Quartet titled "All a-Cryin'" will be premiered in Feb. 2017. Last April, he was honored with an award for creative activities by the Dean of the College of Arts and Sciences at UTC. He participated in the Savvy Musician in Action workshop at the Univ. of South Carolina in June 2016.

CD release October 2016:

American Piano Music Series Volume 2, PnOVA Recordings, featuring works for solo piano by Kent Holiday Jennifer Margaret Barker, Mark Hagerty, Christopher Cook and **Byron Petty**, performed by internationally acclaimed British pianist Martin Jones. Available on Amazon, CD Baby, I-tunes, etc.

Michael Young was the 2016 pedagogical composer for the Kentucky Music Teachers Association. He performed the commissioned work for solo piano, entitled *Six Inventions*, at the KMTA convention at the University of Louisville in October. Earlier this year, the trio Trifecta! released their CD *Cumulus Accumulation* that included Young's *Capriccio for Clarinet, Bassoon, and Piano*.

Leonard V. Ball, Jr.'s ..leaves ~~~ (he.. ~ she.. ~ the.. ~) for flute, viola, and harp was recently recorded in the Czech Republic by members of the Moravian Philharmonic Orchestra. The recording session, along with post editing and mastering, was contracted with PARMA Recordings. Along with serving as Southeastern Composers League Secretary, **Gary Powell Nash** is also Secretary/Treasurer for the CMS South Region. His composition *Fortitude* (2015) clarinet quartet (Eb cl, Bb cl, Bassett horn and Bb bs cl) was premiered by the Novacane Quartet on February 5, 2016 at Indiana University as it also received Honorable Mention in their Clarinet Quartet Composition Contest. Other recent performances of Nash's compositions include *Bricks Up Close* (2014) saxophone quartet, premiered by University of Wisconsin, Green Bay Saxophone Quartet for "A Very Small Consortium Concert", February 25, 2016 at University of Wisconsin, Green Bay. *From Wuteve to Woodall* (2015), a suite for violin, trombone and piano, composed for Douglas Mark, trombone was premiered at the 2016 American Trombone Workshop by Anne-Gaëlle Ravetto, violin, Douglas Mark, trombone and Jung-Won Shin, piano, March 10, 2016, Arlington, VA. *From Wuteve to Woodall*, along with *Stax Suite* (2016) trumpet ensemble will also be performed at the CMS South Regional Conference, February 23-25, 2017 at Austin Peay State University, Clarksville, TN

Work and Play (2012) tenor and cello duo, composed for Adam Mitchell, tenor was premiered by Adam Mitchell and Timothy Holley, cello for Composers of Color Collective Conference, May 28, 2016, North Carolina Central University, Durham, NC. The duo also performed Work and Play for Musica Brevis Cello Music Recital, November 11, 2016, NCCU.

Shepherd's Song At Christmas (2015) SATB choir and trumpet solo was performed by Elon University Chorale for their Fall Concert, December 1, 2016, NCCU.

Gary Powell Nash was promoted to Full Professor at Fisk University in March, 2015.

Rodney Waschka's recent premieres include *Notes for Kent Haruf* for amplified piano premiered by Jeri-Mae Alstofi in Raleigh, *Using the Internet* for unspecified ensemble premiered by the JCA Composer's Orchestra in Indianapolis, and *Wealth Inequality 2016* for percussion trio premiered in Raleigh. In addition, his *A Portrait of Stephanie Spencer* was performed at the Electro-Acoustic Barn Dance in Fredericksberg, VA and his *MAYDAY: Requiem for Those Lost at Sea* was performed at Campbell University. *A Portrait of Jonathan Kramer* and *A Short Letter from a Small Place* were also performed in Raleigh. In September, Waschka presented a paper at the International Computer Music Conference in Utrecht.

Composer and saxophonist **Laurent Estoppey** collaborated and toured with The Moscow Contemporary Music Ensemble, who premiered his 40 minutes piece for ensemble *Annonces Classées (Classified Advertisements)*. This piece is part of a project involving Russian composer Dmitri Kurliandsky and Swiss composer Olivier Cuendet and was performed in Russia between November 16th and 22nd , in Moscow, Alexandrov, Nizhni Novgorod, Perm and St-Petersburg.

Estoppey also released on French label Thödol the 4th issue of his *Quadrilatere* series. For each issue, four composers create a piece then remixed successively by the three others. Feature on this issue: BKGD Audio (aka Alap Momin / Octopus), Thomas Peter and Christian Garcia.

The Electrobrass Conference is seeking music that features a brass instrument and electronics for a Composition Competition! 6-10 finalists and their works will be determined from the submission pool, and they are invited to attend the conference and have their work performed, with the performances spread across the duration of the conference alongside other finalists, clinicians, presenters and other professionals. At the end of the conference, 1st, 2nd, and 3rd place winners will be announced, with cash prizes given.

<u>Eligibility:</u> All composers/artists of any age, gender, race, creed, etc are eligible to submit works. The maximum number of submissions per composer/artist is 3.

<u>Instrumentation:</u> Either solo brass instrument with either fixed or live electronics, or chamber ensemble with at least 1 brass instrument (5 players maximum) with either fixed or live electronics.

Duration: No lower limit, but do not exceed 14 minutes.

Submission Deadline: January 20th 2017, 11:59pm.
